

CRS and FATCA Self-Certification for Individuals

Switzerland has concluded various agreements on the Automatic Exchange of Information/"Common Reporting Standard" (CRS)¹ with several jurisdictions². Based on these agreements as well as based on the FATCA regulations Swiss banks are obliged to collect information from their clients on their tax domicile resp. on their US tax status. The form "CRS and FATCA Self-Certification for Individuals" is intended exclusively for individuals as account holder or beneficial owner.
