Interaction

The most prolonged economic expansion on record for the US came to an abrupt end this year due to the COVID-19 crisis. Each crisis posing a potential threat to economic growth has in recent years repeatedly been combated with the universal remedy of low interest rates and endless liquidity injections. And true to the saying "Never change a winning team", the players on the financial markets are continuing to be fed the same medicine in the COVID-19 crisis. The risk in administering different medicines is that completely new symptoms or effects can arise. The side effects already observable today are an additional inflation of central bank balance sheets and overwhelming state budget deficits. The latter have been reflected in the US in a depreciation of the US dollar and globally in panic-induced gold purchases. So far the equity markets have not yet built up any "central bank resistance", and confidence in the prescribed measures appears unbroken. However, sustainable therapies would be more likely in future to advance the further healing of the ailing economy.

Economic perspectives



Since the market slump in February, the financial markets have made a V-shaped recovery. This development stems from the expectation of a significant economic upturn in the second half of the year. However, a possible end to the recession through monetary policy measures and high expectations in the future should not be confused with the current crisis being overcome. It will still be some time before economic output returns to its precrisis level. This situation poses the risk of a possible rise in corporate insolvencies from autumn.

A study by S&P reaches the conclusion that the default rates of loans with poor creditworthiness are set in a baseline scenario to more than double to 8.5% in the next twelve months. The sectors most at risk from loan defaults are leisure, travel, energy, aviation and the automobile industry.

The way remains uneven

It is not anticipated at present that the expected loan defaults will result in a further European banking crisis. However, what is undisputed is that the earnings situation for banks will deteriorate in the current environment, which is set to accelerate further the market consolidation process brought about by digitalisation. In order to secure long-term competitiveness and increase profitability again, financial institutions will need to take swift strategic action. Radical measures are therefore also unavoidable in the financial sector. (muc)

Markets

End-of-year rally?

Following the V-shaped economic recovery in the third quarter, the further development will decide whether or not there is to be another end-of-year rally. Owing to the ailing labour market, we expect a flattening of growth momentum. The US presidential election in November is creating additional uncertainty. Although an election victory for Joe Biden is priced in, his policy platform remains vague. We remain cautious and favour investments in healthcare, consumer staples and technology. (bae)

Equities Switzerland

Compared internationally, Switzerland has so far held up very well in the COVID-19 crisis. Owing to its low government debt and flexible labour market, the impact has so far remained manageable. Although the strongly weighted pharmaceutical securities were recently under pressure due to discussions about the reduction of US drug prices, the Swiss equity market proved robust. As the economic uncertainties are large, it is among our favourites thanks to its defensive stance. We recommend **Novartis, Sika** and **Vifor.** (bae)



Equities Europe

Europe's economy is forecast to shrink by more than 8% this year. A stabilisation of expectations can be seen in the purchasing managers indices published monthly. This is a sign that sentiment is picking up a bit. At the same time, the weak US dollar and hence the strong euro are curbing exports, a development that can prove painful as the Achilles heel for the European economy. We favour companies with agile strategies such as **Schneider Electric, LVMH** and **Adidas.** (goste)



Equities US

An eventful year is coming to an end. The threat of a renewed lock-down continues to hover pervasively like the sword of Damocles, but the equity markets are rushing from one high to the next. The performance of the technology sector is particularly striking, while the other sectors are exposing the economic problems of the COVID-19 pandemic with their weak performance. The US presidential election will further churn up investors' temperaments. We favour defensive securities such as **Gilead Sciences**, **Walmart** and **Verizon**. (goste)



Bonds

The zero interest rate policy era of the central banks is continuing unabated. The US Fed and other major central banks have intervened in an unprecedented manner in response to the COVID-19 crisis. The liquidity of the central banks has supported the bond markets and further pushed down yields. While in the past investors were able to generate a reasonable return with bonds, in the current low interest environment the fixed income part of the portfolio as a rule primarily serves as a means of capital preservation. We recommend a well-diversified portfolio with an admixture of BBB bonds with a short duration. (cal)
